Vice Chair's Message

by Dave Wulf For my message, I don't want to talk about my upbringing nor discuss my professional career. I would rather talk about what I am politically and what I believe is an important topic. The topic is radical centrism. Say what? I bet most of you have never heard of this term.

Why is this topic important? While no independent radical-centrist presidential candidate emerged in 2012, John Avlon (editor-in-chief of The Daily Beast), emphasized the fact that **independent** voters remain the fastest-growing portion of the electorate. Not to mention a polarized U.S. Congress where nothing meaningful (in a good way) is getting done. I would also argue that more could have been done when Democrats were in control of Congress and the White House in 2009-2010. Such as strengthening Social Security by substantially raising the limit on annual earnings subject to SS taxes, phasing in an increase of the federal tax on gasoline and diesel fuel, and more.

Per Wikipedia, the "radical" in the term refers to a willingness on the part of most radical centrists to call for fundamental reform of institutions. The "centrism" refers to a belief that genuine solutions require realism and pragmatism, not just idealism and emotion. Thus one radical centrist text defines radical centrism as "idealism without illusions", a phrase originally from John F. Kennedy.

Most radical centrists borrow what they see as good ideas from left, right and wherever else they may be found, often melding them together. Most support market-based solutions to social problems with strong governmental oversight in the public interest. Many radical centrists work within the major political parties, but needed in many areas. also support independent or third-party initiatives and candidacies.

> Placing a premium on education as a general rule which applies specifically to politics. "Research" assumes serious thinking, testing ideas, and all the rest. > There is a premium on civility among Radical Centrists. RC requires that all issues anyone champions should be moral.

> When Radical Centrists arrive at new ideas which the Constitution does not address, or when functional problems with the Constitution or its amendments are identified, it is always acceptable to suggest new amendments.

Now that Congress is back in session, it remains to be seen if the Republican leadership will take steps to protect our children and enhance gun safety. When I was home traveling throughout western and central Wisconsin, I heard from many of you about the need to work together and find solutions.

the First Amendment is inviolable and essential to any kind of valid politics. People should be free to express their honest thoughts.

Minimum compromise. This does not mean we never go halfway to meet other people with other political objectives, but it definitely does say that Radical Centrism is about staying true to our sense of morality, and to everything we cherish and regard as crucial to our integrity. Compromise may be a necessary evil but we try to avoid any such thing whenever possible.

If you haven't figured it out already, the values and policies of the radical center lean more toward the Democrats than Republicans. Republicans occasionally have good ideas but they are few and far between and rarely altruistic. It is my belief that for Democrats to win majority seat elections in the future, Democratic candidates in "purple and red" states/districts should embrace radical centrism. This not mean abandoning progressive ideas - far from it. It is about pursuing creative solutions to solve problems with realism and pragmatism.

Wisconsin United to Amend Resolution

For City of La Crosse residents, Wisconsin United to Amend was successful in placing on the ballot a referendum supporting an amendment to the US Constitution to end "corporate personhood" and that money is not speech.

Constitutional Amendment

At the April 3 Spring Election, voters will be asked to vote on the question: "Elimination of state treasurer. Shall sections 1 and 3 of article VI and sections 7 and 8 of article X of the constitution be amended, and section 17 of article XIV of the constitution be created, to eliminate the office of state treasurer from the constitution and to replace the state treasurer with the lieutenant governor as a member of the Board of Commissioners of Public Lands?"

To double-check your voter registration, find your polling place, see your April sample primary ballot, or request an absentee ballot, go to https://myvote.wi.gov/en-us/ and click on the appropriate links.

If you are not registered to vote, register as soon as possible. For the April 3 election, the last day to register to vote online or by mail is March 14, 2018. The following information is from the City of La Crosse website at https://www.cityoflacrosse.org/ content/407/437/1252/1262/default.aspx Anyone wishing to vote in the State of Wisconsin, where they are required to register, has four options to register: **<u>1. By Mail:</u>** Download the Application for Voter Registration (EL - 131). Complete the form and mail it to your municipal clerk's office up to 20 days before the election (5:00 p.m. on the 3rd Wednesday before the election).

Proof of Residence is required for any elector, who is not a military or permanent overseas elector, who registers by mail. If registering by mail, a copy must be included when submitting the registration application.

2. Online: Register online at My Vote Wisconsin up to 20 days before the election. Voters who have a valid State of Wisconsin Driver License or State of Wisconsin ID card issued by the Wisconsin Department of Motor Vehicles (DMV) can register to vote online.

<u>3. In Person:</u> Register in the municipal clerk's office up to 5:00 p.m. on the Friday before the election.

Proof of Residence is required for any elector, who is not a military or permanent overseas elector, who registers in person at the Municipal Clerk's Office.

<u>4. At the Polling Place on Election Day:</u> If you wish to register to vote at your polling place, you must bring proof of your residency.

Proof of Residence is required for any elector who is registering to vote on Election Day. See below for acceptable forms.

In-Person Absentee Voting at your Municipal Clerk's Office (Early Voting)

You can also vote absentee at your local municipal clerk's office. If you apply for an absentee ballot in your municipal clerk's office, or another designated location for in-person absentee voting, you will vote your ballot immediately in the clerk's office, seal your ballot in the proper envelope, and return it to a member of the clerk's staff. No ballots may be taken out of the clerk's office.

You will need to show your acceptable photo ID for voting when voting by in-person absentee ballot. More information about acceptable photo IDs can be found at www.bringit.wi.gov.

When can I Vote an In-Person Absentee Ballot?

Each city, village and town in Wisconsin is responsible for setting the dates and hours of in-person absentee voting for their municipality. To find the dates and hours for in-person absentee voting where you live, contact your municipal clerk.

Who is my Municipal Clerk?

The municipal clerk is the clerk for the City, Village or Town in Wisconsin where you reside. If you do not know who your municipal clerk is, or where the clerk's office is located, please use the MyVote Wisconsin website, myvote.wi.gov, to locate your clerk's contact information. You can also find your clerk by searching a list of all Wisconsin Municipal Clerk Contact Information.



La Crosse United to Amend – Overturn Citizens United

La Crosse United to Amend is a local group working with Wisconsin United to Amend to bring the "We the People" resolution to a vote on the April 3, 2018 election. La Crosse United to Amend collected over 3600 signatures to call for this referendum and provide the residents of the city of La Crosse the opportunity to join 110 governments in Wisconsin, 760 communities across America, and 19 state legislatures to pass a resolution calling for a constitutional amendment to overturn Citizens United.

The Preamble to the U.S. Constitution starts with the words, "We, the People." However, Supreme Court decisions over the past 132 years have given personhood and "free speech" constitutional rights meant only for individuals to corporations, unions, nonprofits and super PACs. In addition, money spent to influence the political process cannot be limited. If we are truly to govern ourselves, we must remove the corrupting influence of big money (Think Koch brothers and Americans for Prosperity) on our political system. This goal of removing big money from politics aligns with the values and principles of the La Crosse County Democratic Party.

The goal of United to Amend is to reclaim our republic by placing limits on how much money can be contributed and spent in American elections to achieve a government of, by, and for the people. The amendment must make clear that corporations are not people, despite Mitt Romney's famous statement in the 2012 presidential campaign. Only individual human beings enjoy constitutional rights. Furthermore, money is not speech, so limiting political spending levels the "playing field" to allow all Americans to participate more fully in the democratic process.

Finally, a special invitation: Wisconsin United to Amend-La Crosse and Viterbo University present an evening with Frances Moore Lappé on Monday, March 5, 2018 at 7 p.m. in the Viterbo University Fine Arts Center Main Theater. Ms. Lappé will discuss her 2017 book *Daring Democracy: Igniting Power, Meaning, and Connection for the America We Want*, coauthored with Adam Eichen. They tell the story of how our democracy has succumbed to the effects of money in politics and provide inspiring advice on the ways ordinary citizens can work to revitalize it. This event is free and open to the public and no reservations are required.
