

Trump Is a Danger to Our Democracy

Note: I read several online articles with a common theme of Trump's behavior over the Memorial Day weekend. They were Michael D'Antonio, "On Memorial Day Weekend, Trump Shows His True Self," Jill Lawrence, "As coronavirus deaths near 100,000, Trump makes America exceptional in all the wrong ways" and David Siders, "Trump's 'rigged election' talk sparks fear of post-election chaos." Below are excerpts from the articles with some of my editing.

While spending two days golfing over the Memorial Day weekend, President Trump unleashed a torrent of angry Twitter posts full of vile, baseless conspiracy theories and falsehoods.

Trump again demonstrated that as his drive for re-election begins in earnest, he will not alter the formula that got him to the Oval Office. His methods depend on divisiveness, anger, and activist rage. Trump is using them as he did in 2016 to energize his base.

Research has shown that many people find their sense of well-being and self-esteem rises when they feel anger or hatred of others. What the Wall Street Journal recently described as "the pleasure of hating" can bring people together to act against a common enemy whether that enemy is real or imagined. In life before politics, Trump conjured up pop culture enemies like Rosie O'Donnell so he could engage in public fights against someone he hated. In his current job, where the consequences are real and serious, he has used the same process but infused it with conspiracy theories about "Deep State" opponents.

Trump intuitively knows the power of this game. The more anger people feel, the less they are inclined toward moderation and compromise. The enraged are also likely to feel more motivated to vote against the object of their hate. Add Trump's ability to demonstrate feelings of hatred and revulsion -- take a peek at his rallies -- and it's as if he is broadcasting an official sanction for everyone to shed the restraints of decency and give free rein to their impulsive hatreds.

Is the president's rage sincere? His affection for theatrics and performance argue that it's all game. On the other hand, as we watch the president stagger through the Covid-19 emergency, we should consider that the cruelty, the arrogance, the rage and deviance are not an act. He is only truly himself when expressing disdain for others or love for himself. Hatred and conceit are his comfort zones, and he returns to them whenever he's under pressure. No president capable of caring for the country would demonstrate the kind of crude and self-serving behavior that Trump exhibits.

Trump believes that anyone whose views differ from his must be an enemy. He surrounds himself with sycophants and gets rid of people who dare to contradict him. He nominates extreme right-wing (and often unqualified) personnel to high government positions.

Trump is dangerous to democracy with his pathological lying. Nearly half of Trump's statements fact-checked by PolitiFact fall into the "false" or "pants on fire" categories. The Washington Post Fact Checker calculates that as of mid-April, President Trump had made 18,000 "false or misleading claims." Even more dangerously, Trump disrespects the role of the free press; routinely insults women, journalists, governors, foreigners, immigrants and people of color; treats the Justice Department as his personal law firm; uses his failed impeachment as license to purge government watchdogs; and ignores, belittles and contradicts his own law enforcement, intelligence agencies and science experts.

Trump's increasingly amped-up rhetoric surrounding the

integrity of the November election is beginning to bring center stage a previously muted conversation. With the president lagging behind Joe Biden in public opinion polls six months before the general election, his opponents are becoming increasingly anxious that Trump may attempt to undermine the results of the election if he loses. Or worse, attempt to cling to power regardless of the outcome.

"He's already set the stage to say it's rigged," said Pete Giangreco, a Democratic strategist who has worked on nine presidential campaigns. "This is part of the Trump autocrat playbook. There's no way this guy's going to win the popular vote, and it's at least 50-50 he's going to lose the Electoral College. So, he's got to come up with something else." Trump's former lawyer Michael Cohen once predicted in congressional testimony that there "will never be a peaceful transition of power" if Trump loses.

We need to end this nightmare with a decisive Democratic victory in November.

Updates Related to the Covid-19 Pandemic

LCDP Office at 1323 Gillette St. - The Democratic Party of Wisconsin has instructed all DPW staff (for La Crosse - Scott Arnold, Peter Klitzke, and Evan Brandes) to continue working from home through June 30. State headquarters **strongly** encourages local Party offices to remain closed at least until the end of June. The DPW and county parties are united with respect to our public-health-forward approach, so as to protect the safety of each other and Wisconsinites across our state as much as possible. When the LCDP office reopens, we will follow the La Crosse County Public Health Guidelines.

The Annual LCDP June Picnic Cancelled - The Executive Board voted to cancel the LCDP Annual June Picnic due to the COVID-19 pandemic and CDC/Gov. Evers guidelines regarding the gathering of large groups of people. We are investigating an alternate activity. Keep posted.

Campaign Signs - The Chair has received inquiries regarding Biden yard signs. We are waiting for information from the DPW and the Biden campaign, as well as state candidates. Nate Timm, Chair of the DPW Rural Caucus, is interested in finding rural locations with good visibility to begin posting large 4x4 signs for Biden. The goal is to place 450 4x4 signs throughout Wisconsin, or about 6 signs per county. Nomination Papers - Thanks to all the individuals who signed nomination papers for the various candidates at the county and state levels.

La Crosse Interstate Fair, July 15-19 - The La Crosse Interstate Fair Agricultural Board will decide on June 8 whether to cancel or hold the Fair with modifications due to Covid-19. If the Agricultural Board decides to hold the Fair, the consensus of the LCDP Executive Board is to not participate in this year's Fair due to health concerns related to Covid-19.
