to be an active part of shaping policy and action...and to shape our Democratic Party itself. And now at this time, more than ever before, is the time we need to empower many more "name only" Democrats to become more actively involved. The potential for significant creativity and regeneration of enthusiasm is huge; even as we are reminded over and again about the obvious risks of failure to be effective.

As a Democratic Party, we have so much more to work with now: our state leadership is eager to engage grass-roots feedback, creativity and involvement. The choices and issues at stake are stark and clear and affect daily lives of most people. We have a year during which we can create multiple opportunities to educate, talk with, recruit dues-paying members, register and enroll voters, mobilize and organize new initiatives and outreach towards many "name only" Democrats who are looking for fresh ways to get their hands on doing more than simply voting on election day. That's why I'm enthused about a year-round office presence and the commitment it will ask of all of us. Such an effort will require many different talents, ideas and perspectives.. and it'll be up to the board to find fresh ways to develop and keep ideas, activities and momentum going. I foresee more person-to-person contacts and organizing over the year. I imagine focus groups helping each other bring local relevance to specific areas of interest and experience, for example.

During my last two years as a board member, I partnered with Cathy Van Maren to facilitate discussion of structural racism's impact on our politics and social power in America.. but also within LaCrosse county as well. The strategy was to use a book discussion group with members of the board, with books such as: "Waking Up White", "Caste", "White Fragility" and "The Sum of Us" as material for study and learning about racism's patterns. The idea is that such patterns do affect us all... especially in areas of justice and power.... We experience the hollowing out of justice and community differently, depending on our racial identity and background...but the ongoing loss is there, and we can't change it until we face it and understand it first. As a result of this effort, our board has a new wealth of ideas and resources to draw upon as we keep working to bring diversity to our local party. We still have much more to do, but we have started what I believe is a key process to being locally relevant.

I welcome the chance to continue this work as a board member, and ask for your support.

At this point, my passions are for racial, social, and environmental justice, and for preserving democracy by electing Democrats to oppose the imposition of a right-wing autocracy on America. Ron Johnson and Mitch McConnell Vote "No" on Voting Rights: The Fight Continues

Last week, the Freedom to Vote Act—a tremendous and urgently-needed bill—went up for a vote in the US Senate. Every Democrat supported it. But Republicans, including Ron Johnson, filibustered it. Until and unless filibuster rules are changed, the bill's progress has halted. Meanwhile, even though Wisconsin's Legislative Reference Bureau completed its report and found, once again, that 2020's election was "safe and secure," the GOP's sham investigations—which in fact are naked attempts to justify voting restrictions—continue.

Johnson also voted against removing barriers to vote by making election day a federal holiday, automatically registering voters at the DMV, allowing for online voter registration, guaranteeing same day voter registration, and mandating a minimum of a 15 day early voting period. The Freedom to Vote Act would enshrine Wisconsinites' right to vote, better equip poll workers, prohibit states from banning voters from receiving food or drinks while waiting to cast their ballot, as well as help prevent harassment or intimidation at the polls.

Ron Johnson's "no" vote was designed to prevent vitally-needed election reforms that would have protected Wisconsinites' voting rights, and would have prevented dark money interests from dumping unlimited and unaccountable donations into elections.

By protecting the dark money influence in our elections, Ron Johnson is once again serving only himself and special-interest allies at the expense of regular Wisconsinites. No amount of dark money will be able to hide that Johnson has completely failed his duties as a United States Senator. So what now? We go local.

Voter protection—the process of working with individual voters and election administrators to ensure that everyone has the full opportunity to exercise their freedom to vote—used to be a "final stretch of the election" type priority. Today, it's a year-round fight. We've got volunteers phone banking to recruit poll workers. We've got staff and volunteers overseeing our year-round voter protection hotline (608-DEM-3232.) We've got a whole team on our staff focused on ensuring that voters have the help they need to overcome roadblocks put in their path by Republicans.

And the Democratic Party of Wisconsin isn't alone an array of independent organizations are fighting day in and day out to protect the rights of voters and the future of our democracy.

We can and will continue to advocate for legislation like the Freedom to Vote Act. And we can and will duke it out for voting rights in the courts. But through it all, we're going to organize, organize, and organize—and then organize some more.

For the GOP, attacking democracy is both a strategy for winning power, and a goal once power is won. For us, saving democracy is both key to victory and why victories are worth winning. The battle lines are clear, and the stakes are high.

This is why the work that all of us do is so essential. And it's a great reason to be proud to be a Democrat.
